**NOTICE TO CREDITORS**

My legal advisers and I have not yet determined the order in which the Examinees will be examined. The specific courtroom in which an examination will be conducted will be determined by the Federal Court on the afternoon prior to the examination.

Following the completion of the examinations, I will send creditors a report advising both as to the outcome of the examinations and as to developments generally in the liquidations of the Companies.
